A. Registration Process and Payment Methods

Trablin International Summit (TIS) offers prices for passes that are tiered to provide discount opportunities for purchasing early. Payments must be received before the corresponding deadlines to qualify for discount rates. If payment has not been received by midnight CET of the deadline date, participants will be charged the next tier pricing. This applies to participants submitting credit card payments that are denied or bank transfers that were not received before this deadline date.

Conference registrations will not be confirmed until the completed form and the correct payment is received and processed by TRABLIN.

Participants should obtain confirmation before organizing travel arrangements.

TRABLIN cannot be responsible for your spam filters blocking your confirmation email. Please be sure your spam filters will allow mail from trablin.com.

Your conference registration fee DOES NOT INCLUDE HOTEL ACCOMMODATION & TRANSPORTATION costs. All assistants are responsible for making their own accommodation arrangements. In case of TRABLIN been able to offer Hotel and/or Airline/Transportation discount codes, this will be communicated via email to participants.

Registrations for participation will not be accepted after due date. All payments should be done before November 8th in order to have your participation confirmed.

D. Participation and Behavior
